- New Commissioners

    - Baltimore Curriculum project
      - Jaqueline Bershard asked, "where the school located?"
        - Presenter responded saying, "5201 York Road, Govans Elementary."
      - He requested approval from the PAC to continue the conservation/beautification of their involvement with the schools project.
        - He mentioned that the city/state did not do anything regarding prior to his team picking up this project: a metal statue on Govans Elementary grounds.



- He recommends that the PAC work with the city to restore the artwork in the schools listed in the project.
